

This time of year brings many visitors to Watermead. migrating Canada and Greylag Geese, Tufted Duck, Pochard, Lapwing, to name but a few. Word soon spreads when a newcomers are spotted - at present for example, we have some Ringed Teal (which originate in Paraguay).

Nor must we forget how fortunate we are to have our own Mute Swans (who mate for life), Heron, Great Crested Grebe, Coot, Indian Runners, Mallard and Aylesbury Ducks, and one lone Magpie Drake (he doesn't seem to mind). Ducks, Swans and Geese can be fed wheat, mixed corn or mist bread, although dry bread can cause problems.

#### A COMMUNITY COMPANY?

Avid readers of the minutes of the residents' committee may have seen a reference to a co-op or company to be formed by Watermead residents. This was my suggestion and I should be grateful for any thoughts. I believe we need a shop/sub post office as a focus for village life. The receivers have not had much success in attracting new businesses to the piazza and one answer is for the residents to step in.

The idea I threw out was that we could set up a limited company, taking advantage of the not inconsiderable expertise and resources of what is not a low-powered community. The aim would be to run a newsagent/sub post office/video store and a grocery, along commercial lines. Shareholders receive а discount memorandum and articles structured so as to give keep the controlling interest in the hands of resident shareholders. Profits would be ploughed back into the community. It may be that other defunct Watermead-based enterprises could also be taken over. Obviously no one would wish to compete against those businesses which already contribute to our community life.

The suggestion may well be on the agenda for the next AGM, but I would be grateful for any feedback (phone 397963, fax 393151). I stress that I have no fixed ideas and have not done a feasibility study - it is a concept only and it is up for discussion. We all have a financial stake in Watermead and a commercially active village centre would do no harm, would it?
